

Cash In Promotion Terms and Conditions

The Promotion

1. Skrill is giving eligible participants cash prizes if they reach a target transaction volume set by Skrill, subject to the following terms and conditions (the "Promotion").

Promotion Period

2. The Promotion runs from Wednesday 20th January 2016 00:00 GMT until Wednesday 3rd February 2016 23:59 GMT (the 'Promotion Period').

Eligibility Criteria

3. In order to participate in the Promotion, you must:
 - a) have a registered electronic money account with Skrill as per the [Skrill Account Terms of Use](#) ("Skrill Account");
 - b) be a Skrill VIP User in accordance with the Skrill VIP Terms and Conditions ("VIP") on 17 January 2016;
 - c) have received an invitation email from Skrill directly.
 - d) not use your Skrill Account for commercial purposes.
 - e) not be an employee or an immediate family member of an employee of any company in the Paysafe group.
 - f) not be a service provider or a direct family member of a service provider of any company in the Paysafe group.
 - g) be at least 18 years of age.
 - h) Not reside in US

The above conditions are collectively referred to as the "Eligibility Criteria".

If you satisfy the Eligibility Criteria you shall be considered an eligible participant for the purpose of this Promotion (a "Participant").

4. How it works

Skrill will send selected VIPs an invitation email to the primary email address registered to their Skrill Account. The invitation will contain a pre-determined transaction volume target (the "Target") the VIP must reach during the Promotion Period in order to receive the cash prize.

Only Eligible transactions (see below) will be counted towards the Target.

If the Participant reaches the Target during the Promotion Period, he will receive the cash prize stated in the original communication. For every further €1000 of Eligible Transactions, the Participant will be credited a further cash prize of €5.

Skrill will pay all cash prizes to the Participant's Skrill Account by Thursday 11 February 2016.

Eligible transactions

 - a) Transactions made using the Participants Skrill Prepaid MasterCard®.

- b) Person-to-Person send money transactions;
- c) uploads to, and withdrawals from, the Participants Skrill Account;
- d) Transactions between NETELLER and Skrill Accounts held by the same Participant;

Skrill reserve the right to disregard any Eligible Transactions for this Promotion that they, in their sole but reasonable discretion, deem an abuse of the Promotion including but not limited to: (a) transactions that have no commercial purpose; (b) multiple transactions that are made to artificially increase the volume of Eligible Transactions; (c) transactions that are not for the personal benefit of the Skrill Account holder; or (d) are prohibited transactions as set out in section 11 of the Skrill Account Terms of Use.

9. The Promotion is conducted solely by Skrill Ltd and does not apply to customers of Skrill USA Inc. or residents of the United States of America.

Skrill reserve the right to remove Participants from the Promotion where Skrill has reason to believe that Participants have: (a) breached or tried to breach these Promotion Terms and Conditions, the Skrill Account Terms of Use or VIP Terms and Conditions as applicable; (b) attempted to circumvent any security or operational procedures; or (d) lost their VIP status.
11. All decisions by Skrill are final and binding and no further correspondence will be entered into.
