

The Skrill and NETELLER 'Club & Country' Promotion

Terms and Conditions

1. The Promotion

1.1 Skrill and NETELLER are awarding three headline prizes in our three prize draws:

1.11 Flights, accommodation and final tickets to the Champions League final in Milan, Italy

1.12 Flights, accommodation and final tickets to Euro 2016 final in Paris, France

1.13 \$/€10,000

1.2 We are also giving away runners up prizes of 20 iPad 4 Mini 16gb, 20 Fitbit Charge and 40 €/\$50 in the 3 prize draws across the 2 part Promotion Period. Cash will be paid directly into the winners Skrill Wallet / NETELLER Account.

2. The Promotion Period

The Skrill and NETELLER 'Club & Country' promotion is a 2 part promotion. Part 1 runs from Monday 4 April 2016 00:00 GMT until Wednesday 4 May 2016 23:59 GMT. Part 2 runs from Friday 27 May 00:01 GMT until 10 July 23:59 GMT (the 'Promotion Period').

3. Eligibility Criteria

3.1 In order to participate in the Skrill and NETELLER 'Club & Country' promotion, you must:

3.1.1 Have a registered account with either Skrill or NETELLER, as the case may be in accordance with the relevant terms of service ("Account");

3.1.2 not use your Account for commercial purposes;

3.1.3 not be an employee or an immediate family member of any of the Skrill, NETELLER or Paysafe group companies;

3.1.4 not be a service provider or a direct family member of a service provider to any of the Paysafe group companies;

3.1.5 be at least 18 years of age;

3.1.6 not reside or be located in any country that Skrill and NETELLER, as the case may be, are prohibited from offering Accounts; and

3.1.7 not reside in the United States of America

The above mentioned are collectively referred to as the “Eligibility Criteria”

3.2 Once you have satisfied the Eligibility Criteria you shall be considered an eligible participant for the purpose of this Promotion (a “Participant”).

4. Eligible Transactions

4.1 A successful send money transaction made from your NETELLER Account to any NETELLER Merchant or from your Skrill Account to a Skrill Merchant during the Promotion Period and

4.1.1 A successful Person-to-Person payment through your NETELLER Account or your Skrill Account

4.1.2 A successful Person-to-Person payment through Skrill iT

A successful application, activation or transaction of/using a Skrill Prepaid MasterCard or NET+ Card

4.2 The following transactions shall not be considered Eligible Transactions:

4.2.1 Uploads to and withdrawals from your Skrill Account or NETELLER Account;

4.2.2 Transactions between linked Accounts with NETELLER VIP status or Skrill VIP status.

4.2.3 Transfers from your Skrill Account to your NETELLER Account or vice versa unless explicitly mentioned in the Boosts (as defined in clause 5.3 below);

4.3 Skrill and NETELLER reserve the right to disregard any Eligible Transactions for this Promotion that they, in their sole but reasonable discretion, deems an abuse of the Promotion including but not limited to, transactions that have no commercial purpose, multiple transactions that are made to artificially increase the volume of Eligible Transactions or transactions that are not for the personal benefit of the Account holder.

4.4 For every transaction (regardless of value) in Eligible Transactions you make during a week, you will earn either one or three tickets into our Prize Draw for a chance to win. Tickets will be awarded for the first 10 transactions each day of the promotion period, and your ticket total will accumulate throughout the 12-day campaign.

4.5 Entries will be awarded for eligible transactions in part 1 (from Monday 4 April 2016 00:00 GMT until Wednesday 4 May 2016 23:59 GMT). All entries collected in this period will be valid for the first prize draw (see the table below). No entries will be available again until Part 2 (from Friday 27 May 00:01 GMT until 10 July 23:59 GMT). Entries earned in part 1 will count for all 3 prize draws and any entries collected in part two will be added on to your total from part 1.

5 Prizes

5.1 There will be 3 Prize Draws during the Promotion Period, as detailed in the below table. Winners will be drawn at the end of each week during the Promotion Period (“Weekly Prize Draw”) from both qualifying Skrill and NETELLER Account holders.

5.2 To increase your number of entries, you can complete a series of actions as defined in Skrill and NETELLER promotional emails as ‘Boosts’. New Boosts will be released intermittently throughout the promotion. Boosts must be completed during the available period as detailed within the email content. Entries will be added to your total number of entries within 48 hours of completion. Boost entries do not count as part of the maximum 10 daily entries but will be added on top. Participants must first make an Eligible Transaction to earn a minimum of one entry into the Skrill and NETELLER Club & Country promotion. Participants who do not have at least 1 entry will not be eligible to receive Boost points.

5.3 Prize winners will be contacted by email and/or phone call through the contact details that are known to either Skrill or NETELLER. Where possible this contact will be made within 72 hours of the prize draw taking place.

5.4 We will use reasonable efforts to notify winners. However, if we are unable to contact winners or if the winner has not responded to us within 2 weeks of the announcement, then we reserve the right to revoke the first winner and randomly select a new winner or to revoke the prize completely.

5.5 All winners in our 3 Prize Draws will be contacted by us and offered the corresponding Prize.

5.6 Where possible, non-cash prizes can be exchanged for cash which will represent 80% of the value of the prize itself as determined by Skrill and NETELLER. Cash alternatives will be

paid directly into the winner's Skrill or NETELLER Account. The decision to offer a cash alternative will be made by Skrill and NETELLER at their sole discretion and the decision made shall be final.

- 5.7 Winners agree that some of their personal information (first name, surname initial and country location; for example John D from Germany) may be published on different Paysafe Group channels including but not limited to emails, social media and online broadcast.
- 5.8 It is the responsibility of the winner to ensure both they and their guests have the necessary travel documents in place where required and we will not be responsible for any delay and/or cancellation of travel as a result of not having appropriate travel documents in place.
- 5.9 If prize winners are unable to attend an experience based prize then we reserve the right to revoke the first winner and randomly select a new winner or to revoke the prize completely.

6. Legal Recourse

6.1 This Promotion is brought to you jointly by Skrill Limited, a company duly registered under the laws of England and Wales under company number 4260907 whose registered office is at 25 Canada Square, London E14 5LQ ("Skrill") and Paysafe Financial Services Ltd., Compass House, Chivers Way, Cambridge, CB24 9AD, UK ("NETELLER"). Skrill and NETELLER are authorised by the Financial Conduct Authority (FCA) under the Electronic Money Regulations 2011 for the issuing of electronic money. By entering the Promotion, the Participant accepts these Promotion Terms and Conditions.

6.2 The present Promotion does not apply to residents of the United States of America.

6.3 Skrill and NETELLER reserve the right to end the Promotion at any time in their sole discretion or to make changes to the Promotion at any time in its sole discretion by giving notice to existing Participants by sending an e-mail to the e-mail address registered with the Participant's Account or by amending these Promotion Terms and Conditions.

6.4 Skrill and NETELLER reserve the right to remove Participants from the Promotion where they have reason to believe that Participants have breached or tried to breach these Promotion Terms and Conditions or the Account terms of service as applicable, or attempted to circumvent any security or operational procedures.

6.5 All decisions by Skrill and NETELLER are final and binding.

6.6 Skrill and NETELLER are not responsible for: (1) any incorrect or inaccurate information, whether caused by Participants, printing errors or by any of the equipment or programming associated with or utilised in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorised human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from participation in the Promotion or receipt or use or misuse of any prize.
