

The Skrill and NETELLER 'Cash Drop' Promotion

Terms and Conditions

1. The Promotion

1.1 Skrill and NETELLER are offering account holders the opportunity to take part in a prize draw to win one of three fantastic prizes. Entries into the prize draw will be awarded for the first 10 eligible Transactions on each day of the Promotion Period per Skrill or NETELLER account. The number of entries into the prize draw will accumulate throughout the Promotion Period.

1.2 Skrill are also giving away daily spot prizes on www.skrill.com, with 10 chances to win 50 Euro each day throughout the Promotion Period (the "Daily Spot Prize").

1.3 The Cash Drop and Daily Spot Prize are subject to the below terms and conditions.

2. The Promotion Period

This promotion runs from Thursday 01 December 2016 00:01 GMT until Wednesday 4 January 2017 23:59 GMT (the 'Promotion Period').

3. Eligibility Criteria

3.1 In order to participate in this promotion, you must:

- 3.1.1 Have a registered account with either Skrill or NETELLER, as the case may be in accordance with the relevant Account Terms of Use ("Account");
- 3.1.2 not use your Account for commercial purposes;
- 3.1.3 not be an employee or an immediate family member of any of the Skrill, NETELLER or Paysafe group companies;
- 3.1.4 not be a service provider or a direct family member of a service provider to any of the Paysafe group companies;
- 3.1.5 be at least 18 years of age;
- 3.1.6 not reside or be located in any country that Skrill and NETELLER, as the case may be, are prohibited from offering Accounts; and
- 3.1.7 not reside in the United States of America.
- 3.1.8 be able to fly to London on 10 February 2017 for 3 nights.

The above mentioned are collectively referred to as the "Eligibility Criteria".

4. Eligible Transactions

4.1 Eligible Transactions are successful:

- 4.1.1 send money transaction made from your NETELLER Account to any NETELLER Merchant (excluding Betfair, Pokerstars, Fulltilt and Exness) or from your Skrill Account to a Skrill Merchant.
- 4.1.2 Person-to-Person payment through your NETELLER Account or your Skrill Account
- 4.1.3 Person-to-Person payment through Skrill iT.

4.2 The following transactions shall not be considered Eligible Transactions:

- 4.2.1 Uploads to and withdrawals from your Skrill Account or NETELLER Account;
- 4.2.2 Transactions between linked Accounts with NETELLER VIP status and/or Skrill VIP status; and
- 4.2.3 Transfers from your Skrill Account to your NETELLER Account or vice versa.

Skrill and NETELLER reserve the right to disregard any Eligible Transactions for this promotion that they, in their sole but reasonable discretion, deem an abuse of the promotion including but not limited to, transactions that have no commercial purpose, multiple transactions that are made to artificially increase the volume of Eligible Transactions or transactions that are not for the personal benefit of the account holder.

5. Cash Drop Prizes

5.1 The prizes for the Cash Drop Prize Draw area as follows

Crystal Maze Dome

The Crystal Maze challenge is supplied by Little Lion Entertainment, East One Studios, Universal House, 88-94 Wentworth Street, E1 7SA. Skrill and NETELLER reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond our control makes it necessary to do so.

5.3 In the Dome, the winner must catch as many gold tickets as possible as the Dome's fans blow them in the air.

5.4 Each gold ticket will be allocated a monetary value. The total number of gold tickets collected by the winner will be countered and the monetary value will be paid into the winners Skrill or NETELLER Account (as applicable) by Friday 17th February days of completing the challenge. If the winner fails to complete the Crystal Maze challenge for any reason, they will lose the opportunity to win the additional prize money.

5.5 Completion of the Crystal Maze may be subject to additional terms and conditions by Little Lion Entertainment. After completing several challenges to winner must collect as many fake paper notes within a set time.

6. Cash Drop Prize Draw

6.2 We reserve the right to reselect a new First Prize winner if the initial winner does not agree or is unable to travel to London on 10 February 2017 to complete the Crystal Maze.

6.3 Prize winners will be contacted by email and/or phone call through the contact details that are known to either Skrill or NETELLER. Where possible contact will be made within 72 hours of the prize draw taking place.

6.4 We will use reasonable efforts to notify winners. However, if we are unable to contact a winner or if the winner has not responded to us within 3 days of the announcement, then we reserve the right to revoke the original winner and randomly select a new winner or to revoke the prize completely.

7. Daily Spot Prizes

7.1 During the Promotion Period, Skrill account holders will have the opportunity to win a daily sport prize of 50 Euro.

7.2 To win the prize, Skrill account holder must login to their account, visit the Cash Drop promotion page and then click the Daily Spot Prize button. Each Skrill Account Holder will only be able to click the button once per day.

7.3 10 times each day, a winner will be selected at random by a computer programme from the people who have clicked the Daily Spot Prize button that day. If the crystal turns red you're unlucky for today. If the crystal turns green you're a lucky winner and will receive a cash reward into your Skrill Wallet within 72 hours.

7.4 The 50 Euro prize will be paid directly into your Skrill Account within 72 hours (where possible).

7.5 Daily Spot Prizes are not available to NETELLER account holders.
