



Skrill Send for Free Promotion Terms and Conditions

1. The Promotion

For a limited time only Skrill Account holders will be able to transfer funds to Sri Lanka, Indonesia, Fiji, Ghana, Kenya, Nepal, Armenia, Albania and the Philippines Mobile Money wallets free of charge (FX fees apply) as part of our 'Send for Free' promotion (the 'Promotion')

2. The Promotion Period

The Promotion runs from Monday 21 March 2016 00:00 GMT until Sunday 31 July 2016 23:59 GMT (excluding send money transactions to Kenya which ran from Monday 21 March 2016 00:00 GMT until Sunday 03 April 2016 23:59 GMT. Send for Free then restarted in Kenya on Monday 25 April 2016 00:00 GMT until Sunday 31 July 2016 23:59 GMT) (the 'Promotion Period').

3. Eligibility Criteria

3.1 In order to take advantage of this Promotion, you must:

- a) Have a registered account with Skrill in accordance with the relevant terms of service ("Skrill Account");
- b) not use your Skrill Account for commercial purposes;
- c) be at least 18 years of age;
- d) not reside or be located in any country that Skrill is prohibited from offering Skrill Accounts; and
- e) not reside in the United States of America

The above-mentioned are collectively referred to as the "Eligibility Criteria"

Collectively referred to as "Mobile Money Wallets".

4.2 The following transactions shall not be considered Eligible Transactions:

- a) Send money transactions from one Skrill Account to another Skrill Account regardless of the territories.

- b) Send money transactions from a Skrill Account to any payment option other than Mobile Money Wallets.

4.3 Skrill reserves the right to disregard any Eligible Transactions for the Promotion that they, in their sole but reasonable discretion, deems an abuse of the Promotion, including but not limited to (a) transactions that are not for the personal benefit of the Skrill Account holder; or (b) are prohibited transactions as set out in section 11 of the Skrill Account Terms of Use.
